- Each player/parent must sign a release holding Kick It/Affiliate Tournament harmless for any injury incurred while participating.

Non-Competition Agreement Statement

(Club/Organization): _____ agrees not to promote, sponsor or otherwise affiliate the Kick It 3v3 Soccer Affiliate Tournament with another 4v4 or 3v3 national soccer tour without the prior written consent of Kick It for a period of 2 years (24 months) from the time of the execution of this agreement.

Information Agreement Statement

(Club/Organization): _____ agrees to provide Kick It with full contact information for each team participating in the above Affiliate Tournament one week after the completion of the event (contact information required by Kick It is included in Affiliate Tournament Requirements Section of this contract). If information is not received one week after the event, the Affiliate Tournament is subject to a \$500 fine. **This information is required by Kick It's insurance agency and is mandatory.*

Termination Policy

Either party listed in this contract may terminate this agreement within 30-days of the above listed event (each event year). Causes for cancellation should include but are not limited to tournament performance, tournament dates, tournament cancellation, etc.

Indemnification

Affiliate Tournament/Kick It agree to and do hereby indemnify, defend and hold harmless Affiliate Tournament/Kick It, their affiliates and related entities, and the respective directors, partners, shareholders, officers, employees and agents of all of the foregoing, from any and all claims, demands, actions, causes of action, damages, liabilities and expenses of any kind arising out of or in connection with, either directly or indirectly, any act or omission of Affiliate Tournament/Kick It, their agents, employees, or anyone acting on its behalf in connection with the indemnifying party's performance of this Agreement. This Section shall survive the expiration or earlier termination of this Agreement.
